



## **Guidelines for completing Vetting Invitation Form (NVB 1)**

Please read the following guidelines before completing this form.

- The Form must be completed **in full** using **BLOCK CAPITALS** and writing must be clear and legible.
- The Form should be completed in ball point pen.
- Photocopies will not be accepted.
- All applicants will be required to present documents to their WSAC to validate their identity.
- If the applicant is under 18 years of age, a completed **NVB 3 - Parent\Guardian Consent Form** will be required. Please note that where the applicant is under 18 years of age the **electronic correspondence will issue to the Parent\Guardian**. This being the case, the applicant must provide their Parent\Guardian Email address on the NVB 1 form.

### **Section 1 : Personal Details**

- Insert details for each field, allowing one block letter per box.
- For Date of Birth field, allow one digit per box.
- Please fill in your Email Address, allowing one character/symbol per box. This is required as the invitation to the e-vetting website will be sent to this address.
- Please allow one digit per box for your contact number.
- The Current Address means the address you are now living at.
- The address fields should be completed in full. No abbreviations.
- **Role Being Vetted For:** The role being applied for must be clearly stated. Generic terms such as “Volunteer” will not suffice.

### **Section 2: Declaration of Application**

The applicant must confirm their understanding and acceptance of the two statements by signing the application form at Section 2 and ticking the box provided.

### **Section 3: Verification of Identity**

For completion by WSAC Officer on presentation of identification documents.
